Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 8.5 crore Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, in at least One (1) Contract of at least 3000 M.T grain storage or godown within the last ten (10) years, with a value of at least NRs 3.8 crore that have been successfully completed in government or semi government organization and completed in a year and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.

- 2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Chandrapur Municipality, Rautahat, Chandrapur, Rautahat, Rautahat, Province Two, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1625000 which shall be valid for 30 days beyond the validity period of the bid.

- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
- 9. Evaluation and Qualification Criteria:

Average Annual Construction Turnover -:

Minimum average annual construction turnover of NRs 8.5 crore calculated as total certified payments received for construction contracts in progress or

completed, within best three years out of last ten years.

Only the net amount shall be calculated after deducting the amount for VAT and such amount shall be adjusted wholesale price index of Nepal Rastra Bank.

For Single Entity: Must meet requirement

For joint Venture: All combined partner Must meet requirements, Each partner Must meet 3 of the requirement,

One partner must meet 4 of the requirements.

Only the net amount shall be calculated after deducting the amount for VAT and such amount shall be adjusted to present value by applying wholesale price index of Nepal Rastra Bank.

- (2) The amount stated should normally not be less than 1.5 x V/T, the estimated annual turnover in the subject contract based on a straight-line projection of the Employer's estimated cost (V), over the contract duration (T) in year. Contract duration less than one year shall be considered one year. The multiplier of 1.5 may be reduced up to 1 (one) in accordance with the size, nature and complexity of contracts.
