Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidder's representatives who choose to attend at 16-05-2021 14:00 hours at the office of Chandrapur Municipality, Chandranigahpur, Rautahat, Province Two, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 525000 which shall be valid for 30 days beyond the validity period of the bid.
