

# *Invitation for Bids*

## *Chandrapur Municipality, Rautahat*

1. Chandrapur Municipality, Rautahat invites electronic bids from eligible bidders for the construction of Irrigation Canal from Santapur to Basantapur (Phase- II), Chandrapur Municipality ward no 8 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:  
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 3 crore  
Minimum Work experience of similar size and nature: 1.7 crore
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Chandrapur Municipality, Rautahat, Chandrapur, Rautahat, Rautahat, Province Two, Nepal or may visit PPMO eGP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
4. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

5. Pre-bid meeting shall be held at Chandrapur Municipality, Rautahat Madesh Province Nepal at 04-01-2023 13:00 hours.
6. Sealed or electronic bids must be submitted to the office Chandrapur Municipality, Madesh Province Nepal through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 13-01-2023 12:00. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13-01-2023 14:00 hours at the office of Chandrapur Municipality, Rautahat Madesh Pradesh Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 630000 which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
